

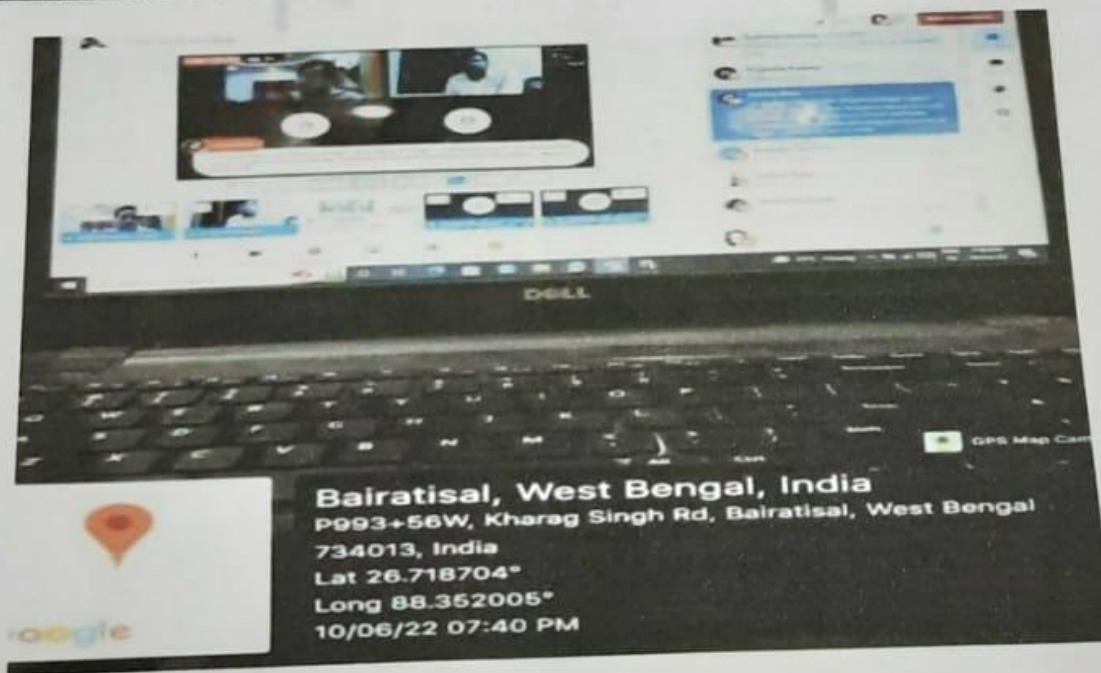
Event name : An online workshop on Goods & service tax for B.Com 2nd, 4th & 6th semester students.
